

# \$500 Electric Vehicle Charger Rebate



## Rebate Checklist

In order to ensure timely approval and issuance of your rebate, please complete the following steps. Incomplete applications may result in delayed payment.

- Read the application Terms and Conditions to determine if you are eligible for a rebate under this program
- Complete this application form
- Attach the following documentation:
  - All receipts for proof of purchase of charger
  - Invoice or other documentation showing electrical installation of the charger
- Submit the application and required documentation to your local utility

## Terms & Conditions

The Power Forward Electrical Vehicle Charger Rebate is provided by Heartland Energy in collaboration with your local municipal utility. Incentives are provided for the purchase of a Level 2 Smart Charger installed by a customer of a participating utility served by Heartland Energy.

- Customers of participating utilities served by Heartland Energy are eligible for rebates.
- Rebates are only available on qualifying Level 2 Smart chargers purchased and applied for in the current calendar year. Applications must be submitted by December 31, 2026.
- Applicant must obtain all necessary permits and comply with all applicable laws, rules, codes, and regulations for the installation of electric vehicle charging equipment.
- Level 2 charger must be connected to WiFi. Applicant agrees to participate in surveys, on-site audits and review of electric vehicle charger usage data. You authorize the qualified provider of electric vehicle charging equipment to share charger usage data with Heartland Energy. Heartland Energy and its participating utilities reserve the right to verify the installation of the rebated electric vehicle charging equipment installed. Rebate may be rescinded if applicant is in violation of these terms and conditions.
- Rebates are available on a first-come, first-served basis and are subject to eligibility and availability of funds. This program is subject to change or termination without notice.
- A copy of proof of purchase/sales receipt and proof of installation must be included with this application and will not be returned.
- Rebates will be issued by your local electric utility in a manner chosen by the utility. Please allow up to 90 days for the delivery of rebates.
- Equipment must be installed by December 31, 2026.
